DID JOHN KEEL EXPERIENCE WEIRD TIME WARP? On Augugust 15th, your Editor, Gray Barker, and Editor James W. Moseley were contacted by John Keel, eminent UFO researcher and writer, to arrange for a neeting where several confidential matters would be discussed, and where he would hand

us an important photograph of a so-called "little man."

This was during my (Gray Barker's) eastern lecture tour, and the evening I would go on the Long John Nebel all-night Show. Trying to agree on a suitable meeting place that all three could find easily, we decided upon the famous Hurley's Bar (though all three of us, it must be said, rarely drink and then in moderation). The meeting was set for 9:00. Jim was delayed by traffic through Harlem and my watch was slow -- so both Jin and I arrived five minutes late. Keel was not there. We had Cokes and waited until 9:30, when we had to leave for a meeting with Long John's producer.

Later Keel phoned Jim quite indignantly. He had been at the bar 10 minutes of nine, and had found it necessary to go to another part of Radio City briefly -- but he returned at 9:10. He sat at the same end of the bar as we, toward the door -- however we did not see each other! It must be explained that all three of us are friends, have seen each other many times, and it would be impossible to consider that we could

not have recognized one another.

Was some sort of weird time warp involved? We believe implicitly

that John was there -- for his veracity cannot be questioned!
DID "SI'S" CAUSE LONG JOHN CANCELLATION? Later that evening I somewhat laughingly told Long John that Ted Owens had been in error when he told me by letter that the "Si's" (Abbreviation for Space Intelligences which the latter allegedly contacts) had caused his "Long John Versus Show" to be cancelled during prime time and switched to four o'clock in the morning. I knew (1) that Long John and Owens had a verbal spat when the "Philadelphia Prophet" appeared on the LJ Show; and (2) that the "Versus" show was indeed still on the air at 8:00. Owens obviously had been confused after hearing the usual rebroadcast of the show at 4:00 A.M.

When I mentioned this to Long John, however, he didn't chuckle, as I thought he would. Instead, a strange, almost frightened look came over his face.

Two weeks later Jim Moseley learned, through trade channels, that the 8:00 show was indeed being cancelled. John probably knew this at the time I mentioned Owen's claim (The famous Long John midnight to 4:00 A.M. show is, of course, still on the air, and will continue, I can happily report).

communication with the "Si's," or Space Intelligences.

"For this reason our organization will be conducting investigations into this matter; hopefully we will contact the deceased's friends, as we have reason to believe that the obtained information was 'passed on' to someone else. Meanwhile, other investigations will be undergone at the site of the Albion UFO. The reports that we have receive indicate that the object emitted a light, hovered over the ground, and later swept into the sky. This took place in a forest southeast of the city.
